Scott Petrie explained to the Board that BHASED is the fiscal agent for Medicaid monies claimed by the districts; these monies are flowed thru to the districts. BHASED employees provide services and claim Medicaid; however, these dollars are given to the district the student resides in.

C. Update on Lighting Project

The lighting project at the Black Hawk Area Education Center is complete.

D. Infinitec

Christan Schrader informed the Board of the Infinitec on-line program; all districts have access to this program for their district personnel. The past usage has been extremely low; this will be monitored over the upcoming school year and discussed prior to renewing in the future. Christan Schrader will give a mini-inservice on this program at the ROE Superintendents' meeting.

Scott Petrie has been the main technical person for BHASED, the Center and Phoenix. For better utilization of Mr. Petrie's roll as Chief Business Official, BHASED will be contracting some of the technical duties.
