

Resolution Establishing Prevailing Wages

WHEREAS, the State of Illinois has enacted the Prevailing Wage Act and

WHEREAS, the aforesaid Act requires that the Black Hawk Area Special Education District of Rock Island County investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Black Hawk Area Special Education District employed in performing construction of public works, for said Black Hawk Area Special Education District.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE BLACK HAWK AREA SPECIAL EDUCATION DISTRICT:

SECTION 1: To the extent and as required by the Prevailing Wage Act, the general prevailing rates of wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Black Hawk Area Special Education District is hereby ascertained to be the same as the prevailing rates of wages for construction work in the Rock Island County area, as determined by the Department of Labor of the State of Illinois as of June of the current year, a copy of that determination being attached hereto and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rates of wages by the Department of Labor of the State of Illinois shall supersede the Department's June determination and apply to any and all public works construction undertaken by the Black Hawk Area Special Education District. The definition of any terms appearing in this Resolution which are also used in aforesaid Act shall be the same as in said Act.

SECTION 2: Nothing herein contained shall be construed to apply said general prevailing rates of wages as herein ascertained to any work or employment except public works construction of the Black Hawk Area Special Education District to the extent required by the aforesaid Act.

SECTION 3: The Black Hawk Area Special Education District Clerk or Secretary shall publicly post or keep available for inspection by any interested party in the main office of the Black Hawk Area Special Education District this determination or any revisions of such prevailing rate of wage. A copy of the determination or of the current revised determination of the prevailing rates of wages then in effect shall be attached to all contract specifications.

SECTION 4: The Black Hawk Area Special Education District Clerk or Secretary shall mail a copy of this determination to any employer and to any association of employers and to any person or association of employees who have filed their names and addresses and have requested copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5: The Black Hawk Area Special Education District Clerk or Secretary shall promptly file a certified copy of this Resolution with the Secretary of State of the State of Illinois.

SECTION 6: The Black Hawk Area Special Education District Clerk or Secretary shall cause to be published in a newspaper of general circulation within the area a copy of this Resolution, and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.
