4. A. Finance Department Report

Dawn Swanson reported she is preparing information for the audit. BHASED switched to new accounting software as of July 1, 2017. However, the audit will be conducted using the information from the previous system.

A 2015 IDEA payment owed to Colona, but never paid, was sent to them. Also, Medicaid payments are now up to date.

Dawn stated she is looking for a foundation to start with in order to provide everyone consistent and accurate data and financial information.
