Students Who Drop Out (17 or older)

- Update IEP Goal Progress

Accepting Electronic IEP from another IL District

- Update Student Information Page
- Verify student information and FACTS form (date, action, reason)
- Review IEP, make any necessary changes, follow Amendment Procedures

Accepting Out of State IEP

- Complete Student Information Page
- Must provide FAPE comparable to those described in the student's IEP.
- Amendment if accepting IEP as written
- Review/Revision if accepting IEP but making changes to what was written
- Reevaluation if team determines insufficient data to determine eligibility, implement existing IEP OR develop new IEP
- Document changes in placement and/or eligibility
- Verify student information and FACTS form (date, action, reason)

Students Who Move in with an Expired IEP and/or Reeval

- Complete Student Information Page
- Verify student information and FACTS form (date, action, reason)
- Must provide FAPE comparable to those described in student's IEP
- Initiate Reevaluation process

Student Leaving A District

- Update IEP Goal Progress
- Verify student information and FACTS form (date, action, reason)

Transfer of Rights Notice

1 year prior to 18th birthday

Delegation of Rights

When 18 years of age

<u>Procedural Safeguards</u>: Must be given to parents at a minimum one time per year.

A copy MUST be given to the parents:

- upon Initial referral, upon reevaluation or parent request for evaluation
- 2. upon receipt of the first State complaint or due process complaint
- 3. upon parent request
